

# Mazeppa Brittanys

1. This Mazeppa Brittany is to be solely owned by the Purchaser(s).
2. Mazeppa Brittanys shall have no liability related to the ownership of the dog. The purchaser shall be solely responsible for any and all liabilities, damages, and costs associated with the ownership of the dog.
3. Buyer has 72 hours to have dog examined by a veterinarian and to personally inspect the dog. Any claims must be made within this time period and will be verified by the Sellers own veterinarian.
4. Buyer agrees to NOT place puppy in a location that may have a communicable disease infestation such as a boarding kennel prior to the puppy becoming fully inoculated (usually 1 year).
5. The Breeder agrees to refund one-half original purchase price, or replace the puppy should the puppy be diagnosed, by a veterinarian approved by the Breeder and convenient for the Purchaser, with an inherited debilitating genetic defect prior to the puppy reaching 12 months of age.
6. Mazeppa Brittanys encourages the Buyer(s) to spay or neuter your puppy at 12 months of age.
7. The AKC registration papers will be provide to Buyer(s). Buyer(s) agree to fully register their puppy with the AKC.
8. Buyer agrees that this dog or bitch is NOT to be LEFT IN A BACKYARD OR KENNEL ONLY. This dog or bitch is sold with the understanding that it was to go to carefully selected parties and that the Buyer(s) stated openly that the dog or bitch would become a member of the family. This is to assure proper development and maintenance of the temperament for which the animal was bred.
9. Buyer agrees to maintain this dog in good health, provide preventive health care including, but not limited to, inoculation, internal and external parasites, and heartworm medication.
10. Buyer further agrees to provide proper exercise as indicated in order to maintain this dog or bitch in proper weight and physical shape. A proper diet consists of top-quality dog food and supplements.
11. At some time, if the Purchaser is unable to provide a proper home for the dog, the Breeder must be notified immediately of the situation. The Breeder will have the option of adopting the animal, or assisting and approving of the proper placement into another home. Under NO circumstances will the dog be placed into a SHELTER.
